Dear Board Members,

I understand the gravity of the decision before you. In my ten years as an elected official, I have been asked to assist in obtaining parole eleven times. This is the first letter I have ever written. Thank you for your willingness to take on such a tremendous responsibility.

In the interest of transparency, I have never met Phillip Meadows. Though I have spent most of my life in Stillwater, our families do not know each other, we never ran in the same circles growing up, nor do we have a long list of mutual friends. I write this letter on behalf of someone who is a virtual stranger to me. Never the less, I am compelled to ask you to grant Mr. Meadows parole.

I am an attorney by trade, having been sworn into the Bar in 2006. One of the primary reasons I ran for office in 2008 was criminal justice reform. I was heartbroken by how much we spend to warehouse individuals convicted of crimes... and conversely, how little we spend to educate our most precious resource. The funding conflicts in our administration of justice have created a system predicated upon having more and more participants in the system. I have spent the last ten years championing reforms, treatment, community sentencing and rehabilitation.

Certainly, Mr. Meadows does not fit the normal profile of a poster-child for criminal justice reform. He had counsel and pled guilty to a heinous, violent crime. This is not a situation where the system is to blame. Mr. Meadows really has no one to blame but himself. And he does- you will see throughout his jacket that Mr. Meadows takes full responsibility for his actions.

However, I believe in criminal justice reform. Three years ago I shepherded a bill through the legislature to add sentencing options to the crime of drug trafficking. Not necessarily a popular stance to take for an elected official. But from that bill, Governor Fallin has been able to
