Computationally intensive tools play an increasingly important role in financial decisions. Many financial problems ranging from asset allocation to risk management and from option pricing to model calibration can be efficiently handled using modern computational techniques. Numerical Methods and Optimization in Finance presents such computational techniques with an emphasis on simulation and optimization, particularly so called heuristics. This book treats quantitative analysis as an essentially computational discipline in which applications are put into software form and tested empirically. This revised edition includes two new chapters: a self-contained tutorial on implementing and using heuristics and an explanation of software used for testing portfolio selection models. Postgraduate students, researchers in programs on quantitative and computational finance and practitioners in banks and other financial companies can benefit from this second edition of Numerical Methods and Optimization in Finance.

Numerical Methods for Optimization in Finance Tobias Lipp, 2012

This dissertation contributes to optimization in finance through numerical methods. The input consists of two parts. In part 1 we propose a numerical method to compute a trading strategy for the hedging of a financial derivative with N hedging instruments. The underlying mathematical framework is local risk minimization in discrete time. The method combines Monte Carlo simulation with least squares regression in analogy to the method of Longstaff and Schwartz. We study the proposed method on two example problems. For both problems the number of hedging instruments is two. One of the hedging instruments is always the underlying asset of the hedging objective. The other hedging instrument is a vanilla put option in the first example and a variance swap in the second example. In part 2 we propose an optimal control approach for the optimization of European double barrier basket options. The basket consists of two assets. The objective is to control the payoff and the rebate at the upper barrier such that the delta of the option is as close as possible to a predefined constant. This gives rise to a control constrained optimal control problem for the two dimensional Black Scholes equation with Dirichlet boundary control and finite time control. Based on the variational formulation of the problem in an appropriate Sobolev space setting we prove the existence of a unique solution and state the first order necessary optimality conditions. Discretization in space by P1 finite elements and discretization in time by the backward Euler scheme results in a fully discrete optimal control problem. Numerical results illustrate the benefits of optimized double barrier options.
