

# Michigan Corporation Registration and Formation

If you are planning to form a Corporation in Michigan then the procedure for registration and formation is as follows.

# 1

## Maintain a registered agent

If you are planning to form a business or professional corporation in Michigan then you will be required to continuously maintain a registered agent in the state pursuant to MI Comp L § 450.1241 (2014). This law is applicable for domestic as well as foreign corporations. ## Corporate Name Reservation

- Identify a name for your business entity
- According to MI Comp L § 450.1212 (2014), a corporate name should contain the phrase or words "corporation", "company", "incorporated", or the abbreviations "Corp.", or "Inc."
- The chosen name should be distinguishable and should not be deceptively similar to the name of any limited liability company, limited partnership, or corporation
- Apply for reservation of name pursuant to MI Comp L § 450.1215 (2014).
- Submit the form though mail or online with the Michigan Department of Licensing and Regulatory Affairs along with the applicable fee. An LLC can reserve its name for a period of 6 months.

## Articles of Incorporation and Certificate of Authority

If you are planning to form a corporation in Michigan, then the most important step is to prepare and file the proper documents for a business corporation. The steps are:

- If you want to register a domestic corporation then you will be required to file "Articles of Incorporation" pursuant to MI Comp L § 450.1202 (2014).
- If your business entity is a foreign corporation then you will be required to file an "Certificate of Authority" to transact business in the state pursuant to MI Comp L § 450.2002 (2014).
- The application or documentation for registration of a corporation can be filed with the office of the Michigan Department of Licensing and Regulatory Affairs, in person or online.
