- 1) Alona purchases one-half equity in the partnership from Alma and AJ for P2,200,000. Payment is to be made directly to Alma and AJ. Alma and AJ each will retain one-half of their respective equities and transfer the other halves to Alona.

Alma, Capital 1,120,000
AJ, Capital 640,000
Alona, Capital 1,760,000

- 2) Alona invests P4,000,000 to the partnership receiving 50% interest in the partnership.

Alma, Capital 2,384,000
AJ, Capital 1,376,000
Alona, Capital 3,760,000

- 3) Alona invests P4,000,000 to the partnership receiving 50% interest. The amount of Alona's investment implies that the property, plant and equipment were carried at amount less than their fair values.

Alona- 3,760,000

- 4) Alona invests P2,400,000 in the partnership and receives 50% interest in capital and income. All partnership assets and liabilities are fairly valued.

Alma- 1,904,000
AJ- 1,056,000
Alona- 2,960,000

- 5) Alona invests P2,880,000 in the partnership and receives 50% interest in capital and profit. The bonus to Alona will be charged against Alma and AJ in the ratio of 3:2, respectively.
