MAINS RULE

- The mortgage industry rules generally fall on the more strict side of rules. It does not fall on the more lenient side of rules. It is the strictest industry rules possible. There will never be leniency from the strictest rules possible.
- The more rules there are, the more strict rules will also increase to protect home from a certain issue that occurs.
