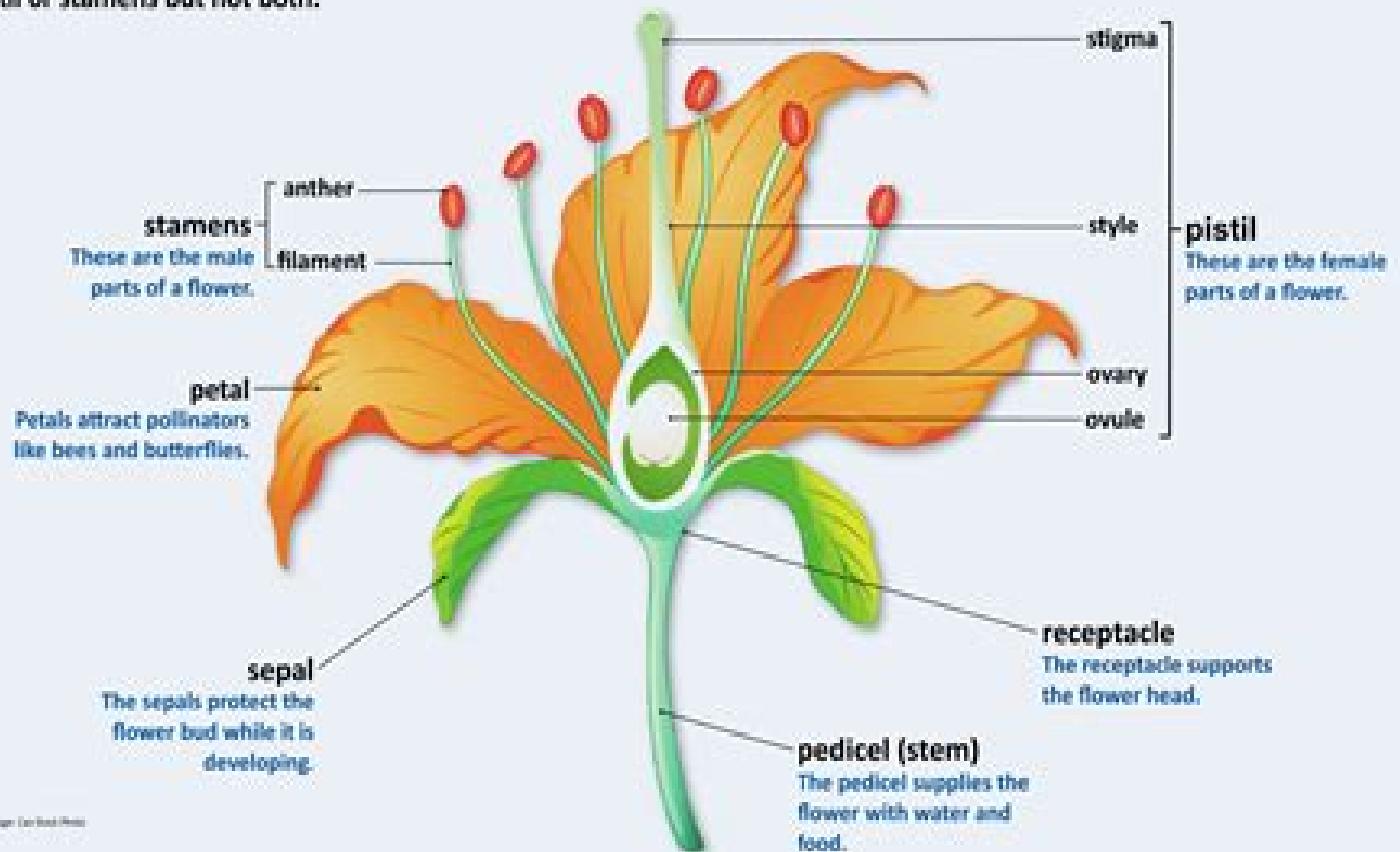


Flower Structure
