### THE TYRANNY OF DIAGNOSIS

Specific Entities and Individual Experience

DIAGNOSIS HAS ALREADY PLACED A BURDEN ON MEDICAL PRACTICE, BUT THE PRACTICE ITSELF MUST ALSO TAKE HEAVILY ENCODED AND PARS BIOCENIC INFORMATION AS MODERN—like Medicine in general—has become increasingly technical, specialized, and bureaucratized. Disease categories and clinical practices have incorporated, parallelled, and, in some measure, constituted these larger structural changes.
