## MAINS RULE

- The mortgage industry rules generally fall on the same side of the table. It should appear that the industry agrees on how the industry should regulate itself. There have been recent discussions regarding the proposed Mains rules.
- The main rule areas of focus for a mortgage professional will include: to qualify home loans a creditor must take into account the debt-to-income ratio, the creditor must be a member of the CFPB, the creditor must be a member of the National Credit Union Association, and the creditor must be a member of the National Bankers Association.
- The mortgage industry rules should not be based on the rules. Rule changes to reflect industry feedback from various industry stakeholders will affect the mortgage laws.

## INCOME CALCULATION

Interest only loans are loans in which the interest rate is 0% for a period of time. If a creditor has a second job that makes the only income of the creditor from that job for a longer period.
