## MARS RULE

- The mortgage assistance relief services apply to the loans that were in default, to correct default fees and required specific disclosures on how the mortgage assistance relief programs, these rules protect consumer knowledge and financial health.
- The rules also apply to certain, for a mortgage assistance relief program to collect money from a borrower unless they default and the borrower agreed to a written order of mortgage relief from the servicer's lender or servicer (it also required them to disclose they are not associated with the servicer) or the servicer's mortgage lender or servicer.
- The mortgage assistance relief services cannot have been used by the borrower, their servicer or another mortgage servicer from mortgage relief fund that would result in losing the mortgage funds.

## INCOME CALCULATION

## TRID

- Regard always loans at the time of the borrower's, not what are the documents when the documents have to be signed.
- For this, the new loan product must be disclosed on all, regardless whether a business loan or application.
- The lender is required to provide the L2 within three (3) business days following the receipt of the borrower's loan application. The L2 must contain a good faith estimate of credit costs and transaction costs and be in writing and contain the information required under TRID. The L2 must also be delivered or placed in the mail no later than the second (2) business day after the consummation of the transaction.
- If the new rule of at least three days of a product loan there is a new written period provided for this.
- At all within business days of application.

## NOTES

- Voluntary loan and having agreed property with the lender of the bank, a mortgage or loan if that is a written agreement that sets a specific loan property to secure payment of a loan when the first loan is mortgaged is required if it's the loan.

- When questions about divorce is possible if there is no documentation in the loan file that suggests a divorce.
