- **Risk and Exposure:** Risk is defined as the uncertainty of loss. Exposure refers to situations that present the possibility of loss, such as owning a house in a flood-prone area.
- **Managing Risk:** There are four primary methods:

- **Insurability Elements:**
  1. **Pure vs. Speculative Risks:** Only pure risks (possibility of loss only) are insurable. Speculative risks, which involve the possibility of gain or loss (e.g., gambling), are not insurable.
  2. **Insurable Interest:** The insured must have a financial interest in the property or person being insured.
- **Other Insurance Terms:**
  - **Peril:** The cause of loss (e.g., fire, theft).
  - **Hazard:** Anything that increases the chance of loss (e.g., faulty wiring is a physical hazard).

## Unit 2: The Insurance Contract

- **Elements of a Valid Contract:**
  1. **Competent Parties:** The parties involved must be legally capable of entering into a contract (e.g., not minors, intoxicated, or mentally incapacitated).
  2. **Legal Purpose:** The contract must be for a lawful purpose (e.g., you cannot insure illegal activities).
  3. **Offer and Acceptance:** One party makes an offer, and the other accepts it. In insurance, the offer is the application, and acceptance is the issuance of the policy.
